- Advocacy & Community Education Committee members came up with steps to inform others about RBHA and how we serve the community.
- RBHA will continue to support at Virginia Association of Community Services Boards (VACSB) level.
- Draft meeting minutes from the Committee are included in today's meeting packet.
- The next Advocacy & Community Education Committee meeting will be scheduled for April.

Executive Committee - Dr. Cheryl Ivey Green

• The Executive Committee has not met since the last board meeting.

Finance Committee - Ms. Denise Dickerson

- The Financial statements and the executive summary for November and December are included in today's meeting packet.
- As of December 31, 2019 RBHA showed a net gain of \$1.5 million and a total net position of \$11.3 million, excluding Regional and Non-authority funds.
- Total cash in the bank at December 31st was \$27.5 million, and RBHA's share of that cash is \$4.01 million. Although Cash balances have rebounded a bit and payments from MCOs has improved, there is still a considerable amount owed to RBHA. Management continues to arrange meetings with all of the MCOs.
- The investment balance decreased by \$7,500 for the month on the \$5.85 million invested at the end of December. Please note, Investments held at Morgan Stanley were liquidated during January and are currently held in cash at Truist Bank (formerly SunTrust Bank).
- RBHA's current operating reserve ratio is at 1.31 or just under 3 months of expenses.
- Total Client AR is \$9.3 million gross and just over \$5.63 million net of the allowance. AR balance was adjusted to reflect only amounts actually billed for the month of December. This method of presenting AR represents a more realistic figure to be collected. The cause of the slow collection of AR has not changed, however Management continues to increase pressure on the MCOs to pay for the claims submitted.
- The note payable for \$3.2 million has been recorded and the long-term portion is presented on the balance sheet in the long-term liabilities section.
- The Finance Committee will meet again on February 26, 2020.
- Resolution from the Finance Committee for consideration by the RBHA Board of Directors: To Renew and Increase the RBHA Line of Credit at Truist Bank (formerly SunTrust) from \$1.5 million to \$3 million.

The Finance Committee of Richmond Behavioral Health Authority recommends the renewal of the line of credit at Truist Bank for one-year and the increase of said line from 1.5 million to 3 million dollars.

Dr. Cynthia Newbille seconded the recommendation that the RBHA Board of Directors authorize the renewal of the line of credit at Truist Bank for one-year and the increase of said line from 1.5 million to 3 million dollars. The Board unanimously approved the recommendation.

Richmond Behavioral Health Authority Board of Directors Chief Executive Officer's Report February 4, 2020

Today's CEO report will be brief. During today's meeting, we will have the pleasure of honoring two recipients of the **2019 Wayne Blanks Service in Recovery Award**. The award presentations will occur in Room 271 at 4:30, followed by a brief reception.

The **2019 Annual Report** is complete. Copies were distributed to the Board along with your regular Board meeting documents.

I was very pleased with the discussion during meetings of the RBHA Finance and Advocacy committees. The numbers are looking good on the financial front, with opportunities remaining related to reconciling our sizeable accounts receivable with the six Managed Care Organizations. I wish to give special thanks to the dedicated efforts of Denise Dickerson, Cheryl Ivey Green, and Irvin Dallas as they aptly go about the Board's business of oversight of our financial health and fiscal operations. I also thank Scott Cannady for assuming the chair of the Advocacy & Community Education committee. Scott is passionate about our work and came prepared with many concrete ideas as to how to re-energize and go about the work of the committee.

Leadership Structure – As reported last month, the RBHA leadership has reorganized around three structures: Executive Leadership Team, Senior Leadership Team, and Leaders (agency-wide supervisors and managers not otherwise assigned to either the ELT or SLT). The Executive team will focus on major policy and practice priorities, fiscal/budget planning, and overall agency health and well-being. The Senior team will focus primarily on cross-agency collaboration and consistency of operations. Finally, the Leader team will focus on training, overall quality improvement, and person-centered problem solving in meeting the diverse and complex needs of those we serve. Several positions on the ELT have been re-titled – Chief Administrative Officer, Chief Financial Officer, and three Chief Operative Officers (previously Division Directors representing mental health, substance abuse, and developmental disabilities). The most recent development is that Dr. Riaz has agreed to transition toward the role of Chief Medical Officer.

VACSB – The 2020 VACSB Legislative Conference was held at the Marriott Hotel (Downtown) on January 21 and 22. RBHA's Board of Directors Chair and Vice Chair participated.

Red Cross Building – Planning around space utilization and building repairs continues. We should have a timetable established within the month for moving in.

City Council – My presentation to the Organizational Development standing committee of City Council has been rescheduled to March 2. The presentation will focus on RBHA's scope of

services and community impact, our growth, and challenges of the health care environment. This would be an excellent time for any attending RBHA Board members to come out and support RBHA as appointees of Council.

North Campus – Daniel and Company continues work on the Children's Services Center. This 1.3 million dollar project will provide appropriate space for child minding in conjunction with the Women's Residential Treatment program and co-location for our Early Intervention Program.

Human Resources, Inc. – Our planning team continues to work out details for assuming HRI assets. Draft management and transition agreements have been submitted for additional review by the HRI Board of Directors.

First Floor Remodeling – We are in the process of procuring design and engineering plans for re-purposing portions of the first floor at our 107 S. Fifth Street location to accommodate expansion of outpatient and medical services, both part of our efforts related to the CCBHC grant and opportunities under STEP Virginia.
